### Outstanding Girl Scout Leader Nomination Form

- Has completed appropriate training or demonstrated competency for the job, or both.
- Has demonstrated leadership skills with the girls.
- Has demonstrated communication skills by completing forms and reports required by the council and the VISTA.
- Maintains ongoing communication with families of troop/group members.
- Has met or exceeded the troop/group size agreed upon by the leader and VISTA cabinet in accordance with the VISTA's membership goal.

The **Outstanding Girl Scout Leader Award** is given **one** time to a registered Girl Scout troop/group leader. This award is approved and presented by the VISTA cabinet at their annual volunteer recognition event.
